WHEREAS the Petitioner above named through his Advocate Sri MD Saleem presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ order or direction more in the nature of Writ of mandamus declaring the action on the part of the Respondents in not extending/paying minimum time scale of pay even though the petitioner has been discharging his services from the year 1995 in spite of petitioner's several personal approaches and written representation dated 14-02-2022 and as being illegal, arbitrary and is in violation of Articles 14, 16, 19 and 21 of the Constitution of India and contrary to the rulings of the Apex Court and consequently direct the respondents to pay the Minimum time scale of pay attached to the Bill Collector post along with arrears forthwith to the petitioner.
