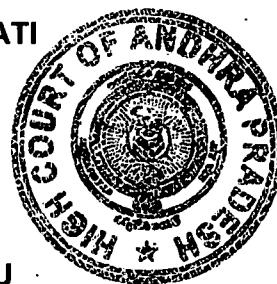

**JUDGMENT:** *(per Sri Justice D.V.S.S.Somayajulu)*

Heard learned Standing counsel for the Sri Venkateswara University appearing for the appellants and learned counsel for respondents.

2. In view of the order passed in similar batch of writ appeals against the interim order which are granted in similar circumstances, this Court is of the opinion that this writ appeal is also allowed.

3. The interim order passed is strictly opposed to two Division Bench judgments passed by this Court in the case of **G.Rama Mohan Rao and another v. Government of Andhra Pradesh**<sup>1</sup> and in W.A.No.1033 of 2022 and batch.

4. For the reasons mentioned in the W.A.No.392 of 2023 and batch, this writ appeal is allowed setting aside the impugned order. No costs.

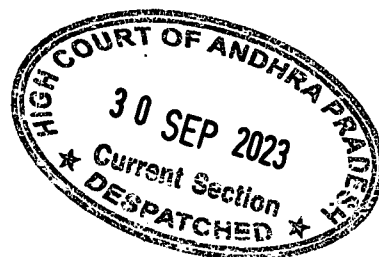
