(C) No.309 of 2003 operating slaughterhouse without any valid consents of A.P.Pollution Control Board, without Effluent Treatment Plant (ETP), without proper solid waste disposal facility and discharging the waste water without treatment into Municipal Drains, the operation of the slaughter house shall remain stayed till the next date of hearing.
