ORDER

"This petition is filed by the respondents No.1 to 3 in the appeal who are the claimants before the Tribunal to vacate the interim stay granted in I.A.No.1 of 2022 and also to permit the first petitioner/claimant to withdraw her share of compensation awarded by the Tribunal (the 2nd and 3rd respondents being minors).

Learned counsel for the first respondent herein/ appellant reported no counter.

Since hearing and disposal of the appeal would take further time, if the interim stay granted is vacated it may frustrate the purpose of filing the appeal. As such, without vacating the interim order of stay, the first petitioner can be permitted to withdraw the amount deposited by the first respondent proportionate to her share as per the direction given by the Tribunal for withdrawal of the amount and to the extent of her share, without furnishing security. It is made clear that amount of share allotted to the minor claimants shall be kept intact as directed in the award. Accordingly, the petition is disposed of."
