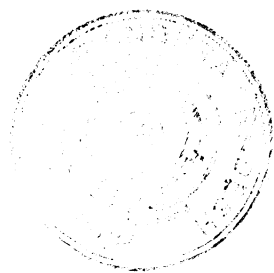

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to grant stay of all further proceedings arising out of RC. No.564/2020/D4 dt- 02/12/2020 of the 2<sup>nd</sup> Respondent including dispossession further not to create 3<sup>rd</sup> party rights, in the interest of justice, pending disposal of WP No. 24406 of 2020, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case).

**ORDER**

Heard the learned counsel for the petitioners. Learned Assistant Government Pleader for Revenue seeks time to file counter in the matter.

Learned counsel for the petitioners inter-alia raised a contention with regard to the invocation of Revision powers by the second respondent after lapse of 20 years. He also places reliance on the Judgment of Hon'ble Supreme Court in State of Punjab & Ors., v Bhatinda District Co-operative Milk Producers Union Ltd. (2007(11)SCC, 363).

In view of the contentious issues, the matter needs to be considered after filing of counter-affidavit.

Let the counter be filed, within a period of three (3) weeks.

Considering the submissions made, there shall be interim direction as prayed for, in respect of the notice dated 02.12.2020 issued to the petitioners only.
