Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction more particularly one in the nature of Writ of Mandamus declare the provisional order cum notice vide Notice No. 87/1012/TPT/UC/2022, dated 06-07-2022 issued by the Respondent No.2 and there by not allowing the petitioner to construct the building as per the sanction plan dated 16-06-2021, as illegal, arbitrary and violation of Art.14, 21 and 300-A of Constitutional of India and consequently set-aside the Notice No. 87/1012/TPT/UC/2022, dated 06-07-2022 issued by the Respondent No.2 and further direct the respondents no 2 and 3 not to obstruct the petitioner in construction of building constructing as per sanction plan dated 16-06-2021.
