ORDER:

"Head the learned counsel for the petitioner and the learned Government Pleader for Civil Supplies. Perused the material available on record.

On careful examination of the impugned Order dt:22.06.2022, it was passed by the 3rd respondent, wherein the authorization of the petitioner is cancelled. It is clear that opportunity for personal hearing is not provided to the petitioner before passing the impugned order which is violation of the principles of natural justice.

This Court, time and again declared that before passing any final order, the respondents shall afford an opportunity for personal hearing to the affected party.

Under these circumstances, in the prima-facie opinion of this Court, it is a fit case to suspend the impugned proceedings.

Accordingly there shall be interim stay as prayed for."


