**ORDER:**

Learned counsel representing for respondent present. None appeared for revision-petitioners.

2. Verification of proceedings in Case Information System (CIS) would show that suit in O.S.No.211 of 2010 on the file of II Additional District Judge's Court, Guntur was 'Disposed' on 26.08.2022 by dismissing the suit while ordering the alternative relief.

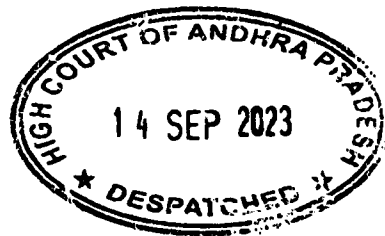
