Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ in the nature of a writ of mandamus or any other appropriate writ, direction, order or orders declaring the action of the respondents 2 to 4 herein in trying to highhandedly dispossess the petitioner from the agricultural land in an extent of Ac.0-41 cents in Sy.No.98/17 situated at Adusupalem Village, Renigunta Mandal, Chittoor District for the purpose of allotment of house sites under the scheme of Navarathnalu/pedalandiriki indlu without payment of the compensation or without following the procedure under law as wholly arbitrary, illegal, without jurisdiction and void and violated the principles of natural justice and affected the petitioner rights guaranteed under Articles 14, 19(1)(g), 21 and 300(A) of the Constitution of India and consequently, direct the respondents 2 to 4 herein not to allot the petitioners land for house sites to an extent of Ac.0-41 cents in Sy.No.98/17 of Adusupalem village, Renigunta Mandal, Chittoor District without payment of the compensation to the petitioner.
