- 2. The learned counsel for the petitioner submitted that without passing any order of suspension or cancellation of authorization, the petitioner is not being provided essential commodities.
- 3. The learned Assistant Government Pleader submitted that the written instructions are not received. However, he stated that so long as the authorization is in force, the supply of commodities would not be stopped, but if authorization is suspended or cancelled, the petitioner would not be supplied any commodities.
- 4. Accordingly, the writ petition is disposed of directing the respondent authorities to supply the commodities to the petitioner, subject to compliance of legal formalities, so long as the authorization is in force. However, this order does not preclude the authorities from taking any action as per law. There shall be no orders as to costs.

As a sequel thereto, the miscellaneous petitions, if any, pending in this writ petition shall stand closed.
