**HONOURABLE SMT. JUSTICE V.SUJATHA**

**WRIT PETITION No.25173 of 2016**

**ORDER:**

The present Writ Petition came to be filed under Article 226 of the Constitution of India seeking the following relief:-

*"....to issue a writ, order or direction more particularly one in the nature of Mandamus declaring proceedings bearing Rc.No.5978/A4/2015 dated 24.5.2016 issued by the 3<sup>rd</sup> respondent as illegal, arbitrary and violation of Articles 14 and 21 of the Constitution of India and consequently set-aside the same and pass..."*

2. Today when the matter came up for hearing, learned Government Pleader for Education has produced a copy of instructions received from the District Educational Officer, YSR District, Kadapa, vide Lr.Rc.No.1Spl/A4/2024, dated 09.01.2024 wherein it is stated that after 2016-17 academic year no further permission was accorded for running Sri Rajamatha EM UP School at Kothapet Village Khajipet (M) YSR District, and subsequently closed down by the Mangement and no school is functioning near the existing ZP High School and MPPS Kothapeta Village where the children of the petitioner are studying and

requested this Court to close the writ petition as the cause in the writ petition does not survive for further adjudication.

3. Considering the above submission, the Writ Petition is dismissed as infructuous. There shall be no order as to costs.

Miscellaneous petitions pending, if any, in this Writ Petition shall stand closed.
