It is represented that the petitioner No.3 herein/A6 is aged about 16 years as on the date of alleged registration of present crime.

In view of the aforesaid reasons, there shall be interim stay of all further proceedings including appearance of the petitioners herein/A4 to A6 only in CC No.428 of 2020 on the file of the learned Judicial Magistrate of First Class, Hindupur, for a period of eight (8) weeks.
