Whereas the Petitioners above named through their Advocate Sri P.V MAHESH presented this Petition filed under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more in the nature of writ of mandamus declaring the action of the respondents 1 and 2 in interfering with the possession and enjoyment of the of the plotted land of the petitioners herein in the private layout of Paidappa Naidu in S.No.335/3 of Madhurawada (V), Visakhapatnam Rural Mandal, Visakhapatnam District, as illegal, void, malafide and arbitrary and consequentially, it is just and necessary that this Hon'ble Court be pleased to direct the respondent authorities to refrain from in any way interfering with the peaceful undistributed possession and enjoyment of the plots purchased and owned by the petitioners in Paidappa Naidu private layout before taking any permissible eviction proceedings against the petitioners in accordance with law.

And Whereas the High Court upon perusing the Writ petition and affidavit filed herein and upon hearing the arguments of Sri P V MAHESH, Advocate for the Petitioners, and of GP for Revenue for the Respondents, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
