Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of the Respondents in not releasing the funds amounting Rs.9,00,000/- to the petitioner in pursuance of MGNREGS + ZP Grant work towards cost of the material supplied for the work "Construction of CC road at Diguvaupallivaripalle H/o. Ganugachintha in Rompicherla Mandal , Chittoor District" as being illegal, arbitrary and violative of provisions of the Andhra Pradesh Panchayat Raj Act, 1994 and Unconstitutional and consequently direct the respondents to release funds amounting Rs. 9,00,000/- to the petitioner in pursuance of MGNREGS plus ZP Grant work towards cost of the material supplied for the work "Construction of CC road at Diguvaupallivaripalle H/o. Ganugachintha in Rompicherla Mandal, Chittoor District".

Heard the learned counsel for the petitioner and the learned Assistant Government Pleaders for the respondents.

2. This writ petition is filed questioning the action of the respondents in not releasing the funds amounting to Rs.9,00,000/- to the petitioner in pursuance of the MGNREGS+ZP Grant work towards cost of the material supplied for the work "Construction of CC road at Diguvaupallivaripalle H/o. Ganugachintha in Rompicherla Mandal, Chittoor District.

3. On the other hand, the learned Assistant Government Pleader appearing for the respondents relying upon the written instructions of the 5<sup>th</sup> respondent dated 17.12.2024 submits that the balance amount of Rs.4,56,348/- including the statutory deductions is due to the petitioner and the same will be paid to the petitioner in due course.

4. In view of the above said facts and circumstances, the respondents are directed to pay a sum of Rs.4,56,348/- to the petitioner by complying with all the formalities as expeditiously as possible preferably within a period of one (01) month from the date of receipt of this order. The written instructions of the 5<sup>th</sup> respondent dated 17.12.2024 shall be made as part of the Court record.

5. Accordingly, this Writ Petition is disposed of. There shall be no order as to costs.

As a sequel, Interlocutory Applications pending, if any, shall stand closed.
