Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction or Writ more particularly one in the nature of Writ of Mandamus by declaring the rejection order Dt.29.09.2019 of the 7<sup>th</sup> respondent in relation to the execution of works under Neeru Chettu Programme vide Agreement No. 2725/18-19 for Rs.9,98,519/-, which was approved for payment by the 9th respondent in the CFMS (Comprehensive Financial Management System) vide Bill No.2018-1393749 (2019-283913), as arbitrary, illegal, devoid of any reasons and one without power or jurisdiction and in violation of Article 19 (1) (g) of the Constitution of India and set aside the same and consequently

direct the Respondents to pay the amounts in respect of works executed under agreements vide CFMS (Comprehensive Financial Management System) Bill No.2018-1393749 (2019-283913) for Rs.9,98,519/-.

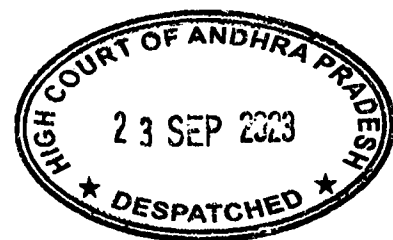
