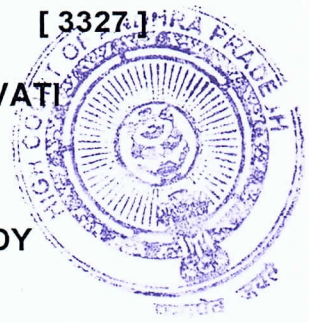

Petition under Section 482 of Cr.P.C, praying that in the circumstances stated in the memorandum of grounds filed in support of the petition, the High Court may be pleased to grant stay of all further proceedings including dispense with the personal appearance of all the petitioners herein in CC No. 234/2023 on the file of the Judicial First Class Magistrate, Movva, Krishna District against the petitioners / Accused Nos.2 to 5, pending disposal of CRLP No. 7337 of 2023, on the file of the High Court.

The Court made the following order :

“Learned Assistant Public Prosecutor takes notice for respondent No.1 and seeks time to get instructions in the matter.

Issue notice to respondents 2 and 3.

Learned counsel for the petitioners is permitted to take out personal notice to respondents 2 and 3 by RPAD and file proof of service before the Registry within a period of three (3) weeks.

In the meanwhile, the presence of the petitioners herein/A2 to A5 only before the trial Court is dispensed with, except on those dates when the learned Magistrate feels that their presence is necessary.

List the matter after four (4) weeks.”
