the respondents in interfering with the peaceful possession and enjoyment of the land to an extent of Ac.3-41 cents in Sy.No.2313/1C of Nandyal Village and Mandal, Kurnool District on the pretext that the same is acquired by the respondents even though the draft notification issued U/s. 4 (1) of the LA Act dated 11-11-1983 was quashed by order dated 5-6-1987 in W.P.No.12435 of 1986 as illegal, arbitrary, unjust and violation of Article 14, 21 and 300-A of the Constitution of India and consequently direct the respondents not to interfere with the peaceful possession and enjoyment of the petitioners land an extent of Ac.3-41 cents in Sy.No.2313/1C of Nandyal Village and Mandal, Kurnool District, in the interest of justice.
