case on the condition that the respondent-workman shall be entitled to withdraw 50% of the amount that is already deposited and is mentioned in the orders of appellate authority in the annexure. The respondent shall be permitted to withdraw 50% on furnishing bank guarantee to the satisfaction of the appellate authority within a period of four (4) weeks from the date of receipt of a copy of this order. The respondent-workman, who wishes to withdraw money should also ensure that the bank guarantee is extended till the issue is finally disposed of by this Court.
