Petition filed under Section 438 of Cr.P.C, praying that in the circumstances stated in the memorandum of grounds filed in support of the Criminal Petition, the High Court may be pleased to release the petitioner on Bail in the event of his arrest in connection with Crime No. 114/2021 on the file of Bommuru P.S., Rajamahendravaram Urban.

The petition coming on for hearing, upon perusing the Criminal Petition and the memorandum of grounds filed in support thereof and upon hearing the arguments of Sri K. VENKATESH, Advocate for the Petitioner, and of Assistant Public Prosecutor for the Respondent, the Court made the following.

### **ORDER**

# THE HON'BLE SRI. JUSTICE D.RAMESH CRIMINAL PETITION NO.7559 of 2021

# ORDER:-

This petition is filed under Sections 438 of Code of the Criminal Procedure, 1973 (for short 'Cr.P.C.') seeking pre arrest bail to the petitioner/ A-20 in the event of his arrest in connection with Crime No.114 of 2021 of Bommuru Police Station, Rajamahendravaram Urban, East Godavari District, for the offences punishable under Sections 177, 199, 207, 406, 417, 423, 420, 426, 465, 467, 468, 471, 474, r/w 34 of the Indian Penal Code, 1860 (for short 'IPC').

- 2. A complaint was lodged on 15.02.2021 against 10 accused alleging that they have obtained loan to the tune of Rs.1,90,00,000/-from S.B.I, Dwaraka Nagar Brach, Visakhapatnam by forging and fabricating some documents; under section 156(3) Cr. P.C and the property covered by the said forged documents are belonging to the complainant/ Kotamsetti Penta Rao. Basing on the said complaint, present crime was registered and petitioner is arrayed as A-20.
  - 3. Heard Sri K.Venkatesh, learned counsel for the petitioner and learned Assistant Public Prosecutor for the respondent-State.
  - 4. Learned counsel for petitioner submits that earlier petitioner has moved an application before the Family Court cum IX Additional District and Sessions Court, Rajamahendravaram and the same was dismissed by an order dated 25.11.2021 in view of pendency of investigation; wherein the learned Assistant Public Prosecutor

submits that 9 witnesses were examined and specific overt acts were made out against the present accused. He further submits that police has to arrest remaining absconding accused persons, as such, he opposed for grant of pre arrest bail to the petitioner.

Learned counsel for the petitioner submits that present bail petition is moved before this Court to submit the changed circumstances that entire investigation is almost completed except filing Charge Sheet. Hence, his case may be considered for grant of pre-arrest bail.

- 5. Learned Assistant Public Prosecutor on the other hand opposed the petition for grant of pre-arrest bail.
- 6. Taking into consideration the fact that the petitioner entire enquiry was completed except filing charge sheet, this Court deems it appropriate to grant pre-arrest bail to the petitioner.
- Accordingly, this Criminal Petition is allowed. The petitioner/ A-20 shall be released on bail in the event of his arrest in connection Crime No.114 of 2021 of Bommuru Police Rajamahendravaram Urban, East Godavari District, on condition of executing self bond for Rs.20,000/- (Rupees twenty thousand only) with two sureties for a likesum each to the satisfaction of the Station House Officer, Bommuru Police Station, East Godavari District. Petitioner shall co-operate with the investigation. In case petitioner fails to cooperate with the investigation, the prosecution is at liberty to move an application for cancellation of bail.

Consequently, miscellaneous applications pending, if any, shall stand closed.
