### ORDER:

This Writ Petition under Article 226 of Constitution of India is filed for the following relief:

"...to issue writ order or direction more particularly one in the nature of writ of mandamus declaring the high handed action of respondents No. 4 and 5 in not allowing the petitioner to operate Fair Price shop No.1046014 Gopichettaypalle village, Karvetinagaram Mandal, Chittoor District even though she is appointed as fair price shop dealer on compassionate grounds vide proceedings Roc.A1/343/2024 dated 28.10.2024 of 4<sup>th</sup> respondent illegal, arbitrary violation of G.O.Ms No.4 of Civil supplies Department, Andhra Pradesh dated 28.02.2014

besides contrary to Article 14,19,21 of Constitution of India and consequently direct the 5<sup>th</sup> respondent to implement the orders issued by 4<sup>th</sup> respondent in appointing the petitioner vide Roc.A1/343/2024 dated 28.10. 2024 and pass such other order or orders...."

# 2. The case of the petitioner is briefly as follows:

The husband of the petitioner died on 04.12.2022. On her application to appoint her as fair price shop dealer on compassionate grounds basing on the G.O.Ms.No.4 of Civil Supplies Department, Andhra Pradesh dated 28.02.2014, after due enquiry, the 4<sup>th</sup> respondent appointed her as dealer for the fair price shop No.1046014, Gopichettayapalle village, Karvetinagaram Mandal, Chittoor district vide proceedings ROC.A1/343/2024 dated 28.10.2024. But inspite of appointment orders issued by the 4<sup>th</sup> respondent, authorization was not issued by the 5<sup>th</sup> and the 6<sup>th</sup> respondents. The petitioner, with her children, is financially suffering for their livelihood, and constrained to file the petition. Hence, the writ petition is filed.

- 3. The learned counsel for the petitioner submitted that though the petitioner had been appointed as a dealer, the authorities had failed to provide her commodities for supply. The matter was adjourned to 02.12.2024 and 09.12.2024 for instructions. Yet no written instructions have been sent to the learned Assistant Government Pleader.
- 4. As such, the writ petition is disposed of directing the respondent authorities to implement the proceedings ROC.A1/343/2024 dated 28.10.2024

forthwith and do the needful for enabling the netitioner to supply the

forthwith and do the needful for enabling the petitioner to supply the commodities.

There shall be no orders as to costs.

As a sequel thereto, the miscellaneous petitions, if any, pending in this writ petition shall stand closed.
