Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of the Respondents No. 5 and 6 in not preventing the Respondents No. 7 to 11 from carrying on illegal construction without plan and permission from the 6th Respondent in respect of the Petitioner land admeasuring an extent of Ac 4.00 cents in Sy.No.250/11, Miniki Village, Ramasamudram Mandal, Annamayya District, pending disposal of ROR Appeal vide ROC.No.A2/3185/202 0 before the concern authority as illegal arbitrary, unjust and not consider the Petitioners representations dated 29.10.2024, 30.08.2024 and 27.08.2024 and according to the provisions of the Andhra Pradesh Gram Panchayat Land Development (Layout and Building) Rules, 2002 and violation of Articles 14, 19 and 300-A of the Constitution of India and consequently direct the Respondents No. 5 and 6 to demolish the illegal construction constructing by Respondents No. 7 to 11 in respect of the Petitioner land admeasuring an extent of Ac 4.00 cents in Sy.No.251/10, Miniki Village, Ramasamudram Mandal, Annamayya District.

The grievance of the petitioner is that without obtaining any permission from the concerned authority, the unofficial respondents are constructing the building in the property belongs to the petitioner herein. If the same is completed it will cause prejudice to the petitioner herein.

Therefore, there shall be an interim direction to the unofficial respondents not to proceed with the construction and the Panchayat Secretary is hereby directed to obtain photographs of the nature of the property as on today and file counter within a period of three (3) weeks from today."
