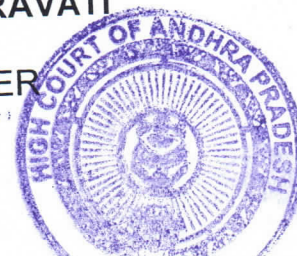

stated in the affidavit filed in support of the petition, the High Court may be  
pleased to stay of all further proceedings in H.M.O.P. No. 54 of 2024 on the file  
of the Civil Judge (Senior Division) court at Kovur, SPSR Nellore District  
pending disposal of the above Tr.C.M.P.

The petition coming on for hearing, upon perusing the Petition and the  
memorandum filed in support thereof and upon hearing the arguments of

Sri KOTHA NAGA SURYA RAO Advocate for the Petitioner and the Court made the following.

**ORDER:**

**“Heard learned counsel for the petitioner.**

**Learned counsel for the petitioner would contend that the petitioner is working as a Civil Assistant Surgeon at Achanta village, West Godavari District and due to the matrimonial disputes in between the petitioner and the respondent, the petitioner/wife is residing at her parents’ house at Achanta village.**

**Learned counsel for the petitioner further contended that the petitioner also filed a complaint against the respondent under Section 498-A of Indian Penal Code before the Achanta Police Station and on the same, charge sheet has been filed, which is pending before the Court of the First Additional Judicial Magistrate of First Class, Palakol, West Godavari District. He would further contend that to cause inconvenience to the wife, husband filed H.M.O.P.No.54 of 2024 before the Court of the Senior Civil Judge at Kovur, SPSR Nellore District seeking dissolution of marriage.**

**Learned counsel for the petitioner further contends that the distance in between the Kovur and Achanta is approximately 400Kms and it is very difficult for the petitioner to attend before the Court of Senior Civil Judge at Kovur for each and every adjournment and that she is constrained to file this application.**

**Perused the record.**

**Considering the submissions made by the learned counsel for the petitioner and for the reasons mentioned in the accompanying affidavit, there shall be an interim stay on all further proceedings including the appearance of the petitioner herein i.e. the respondent in H.M.O.P.No.54 of 2024 on the file of the Court of the Senior Civil Judge at Kovur, SPSR Nellore District till 17.02.2025.**

Learned counsel for the petitioner is permitted to take out personal notice to the respondent through Registered Post with Acknowledgment Due and file proof of service before the Registry."
