# THE HONOURABLE SRI JUSTICE HARINATH.N Writ Petition No.31543 of 2012

## **ORDER:**

The petitioner is aggrieved by the Award passed by the Labour Court, Anantapur in I.D.No.118 of 2011 dated 25.04.2012. Whereby, the Labour Court had modified punishment imposed on respondent.

- 2. The Labour Court has set aside the said punishment and directed the petitioner to restore the past service with increments and attendant benefits on notional basis from 13.05.2008 and the respondent is entitled for monetary benefits from the date of passing of the Award. Aggrieved by this order the present Writ Petition is filed.
- 3. Considering the trivial allegations against the respondent and the manner in which the I.D. has been decided by the Labour Court. This Court finds no grounds to interfere with the Award.
- 4. Accordingly, the Writ Petition is dismissed. No order as to costs.

As a sequel, Miscellaneous Petitions pending, if any, shall stand closed.
