The present batch of appeals were preferred in the year 2002 under section 54 of the Land Acquisition Act challenging the award made on 19.12.1996 by the Land Acquisition Judge – III, Patna.

Thus, there is delay of almost six years in preferring the appeals.

I have perused the applications for condonation of delay.

Mrs. Sheela Sharma, learned counsel for the respondents, submitted that similarly situated F.A. No.294 of 2002 has been dismissed on the ground of limitation on 17.4.2007, wherein it has been held as follows:

"In view of the orders passed in F.A. No.315 of 2002 with reference to I.A. No.1507 of 2003 on 25.1.2005 and the order of the Supreme court passed in Special Leave to Appeal (Civil) OC 8766/2005 filed as against the order dated 25.1.2005 in F.A. No.315/2002, the present I.A. is also rejected on the same grounds. Since the I.A. application has been rejected this appeal becomes barred by limitation. As such, it becomes incompetent and is hereby dismissed."

In view of aforesaid, the applications filed for condonation of delay in these appeals stand rejected and as a natural corollary the appeals also stand dismissed. There shall be no order as to costs.
