This order will dispose of WP(C) No.4130/2019, WP(C) No.4133/2019; WP(C) No.4151/2019; WP(C) No.4166/2019; WP(C) No.4167/2019; WP(C) No.4247/2019; WP(C) No.4506/2019; WP(C) No.4513/2019; WP(C) No.4580/2019; WP(C) No.4618/2019 and WP(C) No.5045/2019.

Heard Mr. K.N. Choudhury, learned senior counsel, assisted by Mr. R. Singha, learned counsel; Mr. R.P. Sharma, learned senior counsel; Mr. P.J. Saikia, learned counsel and Mr. D. Mahanta, learned counsel for the petitioners. Also heard Mr. B. Gogoi, learned standing counsel, Health Department.

In this batch of writ petitions, petitioners have challenged legality and correctness of the communication dated 06.06.2019 of the Director of Health Services, Assam addressed to the Joint Director of Health Services informing the latter about a list containing names of Grade-IV staff, whose appointments have been found to be fake by the Scrutiny Committee and directing the Joint Directors to issue individual show cause notices; as well as consequential show cause notices issued to the individual petitioners.

This Court has passed *interim* order in all the cases to the effect that impugned show cause notices issued to the petitioners should not be acted upon.

Petitioners are serving as Grade-IV employees in different establishments of Joint Director of Health Services in the State of Assam. Their appointments were suspected to be not genuine and accordingly they were not paid salary. This led to filing of a large number of writ petitions before this Court. In WP(C) No.3051/2018 and other connected cases, this Court passed order dated 18.05.2018 to the effect that since the State Government had decided to constitute Screening Committee to find out non-genuine employees, petitioners should avail such opportunity to prove their bonafides. It was directed that if anyone was found to be non-genuine, the authority should indicate the precise deficiency and afford

opportunity to the affected employees before taking adverse action. With such directions, the said batch of writ petitions were disposed of.

Notwithstanding such direction of this Court, impugned communication and subsequent show cause notices were issued.

Director of Health Services, Assam has filed an affidavit. In the said affidavit, it is stated that a decision has been taken by the Health Department to withdraw the impugned show cause notices and to issue fresh show cause notices mentioning the specific deficiencies found against each illegal fake employee, including the petitioners, so that each show caused employee gets an opportunity to know his/her deficiency and to respond effectively. In this regard, direction has been issued on 05.07.2019 to the Joint Director of Health Services of the concerned districts, who had issued the impugned show cause notices, to withdraw those show cause notices and to issue fresh ones indicating specific deficiency.

In view of the stand taken by the respondents, immediate grievance of the petitioners has been redressed.

Accordingly, all the writ petitions are disposed of with liberty to the respondents to proceed in accordance with law.
