## **ORDER**

Heard Mr. D. Chakraborty, learned counsel appearing for the applicants.

This I.A. has been filed with a prayer to vacate/modify/alter the order dated 24.05.2019 passed by this Court in I.A.(Civil) No.1776/2019 arising out of FAO No.29/2019.

Mr. A. Chetia, learned counsel for the OPs submits that today the matter has been listed for the first time and therefore, he be granted three weeks time to obtain instruction and file objection, if any. The prayer is reasonable and therefore, is allowed.

At this stage, Mr. Chakraborty, learned counsel for the applicants, has expressed apprehension and submitted that after the change of pecuniary jurisdiction of the Civil Courts there is a probability that this matter may not be listed before the High Court. However, since the applicants are seeking modification of the order passed by the High Court, regardless of the change of pecuniary jurisdiction, the said issue has to be resolved by the High Court itself.
