COMMON ORAL ORDER (PER: HONOURABLE THE CHIEF JUSTICE MR. VIKRAM NATH)

1 the Shri Kshitij Amin. leaned counsel representing the Union of India and the Central Board of Direct Taxes has prayed for one last opportunity to come with their response in this group of matters which primarily relates to challenge to the amended provisions in Section 115BBE of the Income Tax Act. As prayed, two weeks time is granted and it is made clear that no further more time will be granted as these petitions are pending by more than six months and the first notice was issued in the month of February, 2020. We may also note here that the interim relief is operating in these petitions, as a result of which Shri Manish Bhatt, learned Senior Advocate representing the Income Tax Department in all these petitions states that in most of the petitions counter affidavit (affidavit in reply) has already been filed. However, in the remaining matters in which affidavit in reply is not filed, he would file the same within two weeks.

Learned counsels for the parties who have already received affidavit in reply and who may receive the affidavit in reply after this order, may file their rejoinder affidavits within the next two weeks of the receipt of the reply affidavit.

3 Let these matters be listed on 01.10.2020. It is made clear that these matters will be finally heard on the next date. All the counsels for the parties may come prepared for final disposal of these matters. The interim order granted earlier to continue till the next date fixed.

- Since we have already directed that these matters will be listed for final disposal and legal questions are to be considered, it would be appropriate that the learned counsels for the parties may exchange the relevant case law on the point at least one week in advance of the next date fixed and also file the same before the Court.
- Shri Sudhir Mehta, learned advocate states that one of his matters being Special Civil Application No.6444 of 2020 has been left out from the group and as such the same also be tagged and may be listed on the next date. Mr. Manish Bhatt, learned Senior Advocate will check up and if counter is not filed, same may be filed within the time allowed.
- 6 Shri Chintan Dave, learned advocate has informed that three matters of learned advocate Shri Darshan Patel being Special Civil Application Nos.5637, 5638 and 5639 of 2020 were earlier directed to be listed before another Bench, but now that situation does not exist and as such they also may be tagged with this group of petitions.
