Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ Order or Orders, more in the nature of Writ of Mandamus declare the impugned Proc.No.ES/ES/WA/JANG/SCAS/0536 dt.22/12/2021 issued by the 1st respondent allotting the petitioner to Janagoan district though she come under spouse category her option to Warangal district while considering juniors is clearly illegal, unjust and discrimination and set aside the same, and consequently declare that the petitioner is entitled to be re-allocated to Warangal district under spouse category who is working School Assistant in Warangal district on allotment with all consequential benefits.

# THE HON'BLE SRI JUSTICE K.SARATH WRIT PETITION No.4946 of 2023

## ORDER:

Heard the Learned counsel for the petitioner and Learned Government Pleaders for Services-I appearing for the respondents and perused the record.

- 2. Learned counsel for the petitioner contends that against the allotment order vide Proc.No.ES/ES/WA/JANG/SCAS/0536, dated 22.12.2021, the petitioner had filed a spouse appeal dated 24.12.2021 and the said appeal is pending for consideration.
- 3. It is further contended that the respondents have issued posting orders in contravention of instructions issued by the Chief Secretary, Government of Telangana, vide Memo No.1655/SPF-I/2021-6, dated.22.12.2021, where under the authorities have been directed to dispose of spouse category cases relating to allotment of cadre before issuing posting orders.

- 4. Without expressing any view on the contention, urged, since it is admitted that the petitioner has already availed the remedy as provided under Regulation 27 of guidelines issued under G.O.Ms.No.317, General Administration (SPF-I) Department. 06.12.2021, pending further orders, the respondents are hereby directed to dispose of the said appeal dated 24.12.2021, in accordance with law within four (4) weeks from the date of receipt of copy of this order.
- 5. With these observations, the writ petition is disposed of. There shall be no orders as to costs.
- Miscellaneous petitions, if any, pending in this 6. writ petition, shall also stand disposed of.
