WHEREAS the Petitioner above named through his Advocate Sri Ravi Kondaveeti, presented this Petition under Article 226 of the Constitution of India, praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus declaring the action of the respondents in issuing proceedings No. TS/RO/HYD-I/Higher Wages/PPO No.109926-2019/721 dt. 20-12-2019 by the 3<sup>rd</sup> Respondent as wholly illegal, arbitrary, without jurisdiction, violative of Articles 14, 16 and 21 of the Constitution of India apart from being violative of principles of natural Justice and consequently declare that the petitioner is entitled for payment of higher pension without deductions;
