Petition under Section 151 of CPC, praying that in the circumstances stated in the affidavit filed in the writ petition, the High Court may be pleased to direct the respondents to consider the claim of the petitioner for re-allotment to Rangareddy district under spouse category by disposing of appeal dt.24-12-2021, pending disposal of WP No. 9688 of 2022, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following. (The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER:

"Heard learned counsel for the petitioner, learned Government Pleaders for Services-I & II appearing for respondents and perused the record.

Petitioner contends that against the allotment order dt.21.12.2021 the petitioner had filed an appeal before the appropriate authority on 24.12.2021 on spouse ground and the said appeal is pending consideration.

It is further contended that the respondents have issued posting orders in contravention of instructions issued by the Chief Secretary, Government of Telangana, vide Memo No.1655/SPF-I/2021-8 dt.24.12.2021, where under the authorities have been directed to dispose of spouse category cases relating to allotment of cadre before issuing posting orders.

Without expressing any view on the said contention urged, since it is admitted that the petitioner has already availed the remedy as provided under Regulation 27 of guidelines issued under G.O.Ms.No.317 General Administration (SPF-I) Department, dt.06.12.2021, pending further orders, the respondents are hereby directed to dispose of the said appeal on or before 13.04.2022 in accordance with law.

Liberty is also granted to the petitioner to file spouse certificate before the appropriate Authority, on or before 15.03.2022.

It is further made clear that while considering the appeal, the respondents shall keep in mind the intent and purport behind the Circular instructions issued vide Memo No.1655/SPF-I/2021-8 dt.24.12.2021 by the Chief Secretary to Government relating to posting of employees in newly allotted cadre under Spouse Category."
