WHEREAS the Petitioner above named through his Advocate SRI P V KRISHNAIAH presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly one in the nature of a writ of Mandamus under Article 226 of the Constitution of India, declaring the Proceedings Rc.No.510/VC/2021-1, dated 13-05-2021 issued by the 1st Respondent as arbitrary, illegal, discriminatory, malafide, unconstitutional violating Articles 14, 16 and 21 of the Constitution of India, apart from attaching stigma, and contrary to the law laid down by the Honble Supreme Court in Somesh Tiwari Vs. Union of India and others, reported in (2009) 2 Supreme Court Cases 592, as well as the law laid down by the Hon'ble High Court of Judicature of Andhra Pradesh at Hyderabad in P. Anjaneyulu Vs. Chief Manager, A.P. Circle, Bharat Sanchar Nigam Ltd. Govt. of India, Hyderabad and another reported in 2001 SCC Online AP 268. (2001) 3 ALD 313 (DB). (2001) 4 SLR 485 (AP) (DB), and set aside the same, and issue consequential directions directing the Respondents to forthwith allow the

Petitioner to continue as Administrative Officer in the office of the 3rd Respondent with all consequential benefits, such as arrears of salary etc.,

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri P V KRISHNAIAH Advocate for the Petitioner, Ms Rachana Vaddepalli Standing counsel for respondent Nos.1 and 3 and GP for Services II who takes notice to respondent Nos.2 and directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
