Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or direction particularly one in the nature of Writ of Mandamus declaring the action of the respondents in seeking to construct a bund as part of beautification of the Nalla Cheruvu in the patta land of the petitioners in Sy.No.27 to Sy.No.46 and Sy.No.68, 70 to 73 situated at Kukatpally village and Mandal, Medchal and Malkajgiri District and also to declare the action of the respondents in seeking to construct Sewerage Treatment Plant (STP) in the aforesaid land of the petitioners without following the procedure prescribed under law and without paying compensation as illegal, arbitrary and violative of Article 300-A of the Constitution of India and consequently direct the respondents not to proceed with the construction of bund as well as Sewerage Treatment Plant (STP) in the aforesaid lands of the petitioners without following the procedure prescribed under law.
