AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri Police Venkat Reddy Advocate for the Petitioner, Public Prosecutor for Respondent No.1 directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

are directed to show cause on or before 22.04.2022 to which date the case stands posted as to why in the circumstances set out in the petition and the memorandum of grounds filed therewith (copy enclosed) this CRIMINAL PETITION should not be admitted.

#### IA NO: 1 OF 2022

Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the petition, the High Court may be pleased to Stay all Further Proceedings including the appearance of Petitioner in C.C.No. 2192 of 2018 on the file of the XXXIII Additional Metropolitan Magistrate, Cyberabad at Malkajgiri, Ranga Reddy District pending disposal of CRLP No. 2659 of 2022, on the file of the High Court.

The Court made the following:

## **ORDER**

Notice to 2<sup>nd</sup> respondent.

Personal notice is permitted.

List on 22-04-2022.

Perusal of the record would reveal that there are disputes between the petitioners and 2<sup>nd</sup> respondent with regard to land admeasuring Ac.10-08 gts., in Sy.No.268 situated at Rampally village, Keesara Mandal, Medchal Malkajgiri District. A suit vide O.S.No.874 of 2017 filed by the 2<sup>nd</sup> respondent and his wife against the 1<sup>st</sup> petitioner and another for declaration and perpetual injunction is pending.

The 2<sup>nd</sup> respondent had also filed two interlocutory applications vide I.A.Nos.638 and 639 of 2017 in the said suit seeking interim injunction and also a direction to the defendants in the said suit not to alienate the subject property. The said I.As. were dismissed by the trial Court vide order dated 07-09-2017. It is a contest order and there is clear finding in the said order that the 2<sup>nd</sup> respondent is not in possession of the said property.

Perusal of the record would reveal that on the complaint lodged by 1<sup>st</sup> petitioner, Police have registered a case against the 2<sup>nd</sup> respondent and others for the offences under Sections 447 and 506 r/w.34 of IPC and on completion of investigation Keesara Police filed charge sheet and the same was taken on file vide C.C.No.182 of 2016. Vide judgment dated 28-02-2020, learned Magistrate has convicted the 2<sup>nd</sup> respondent and others. Though the said common order dated 07-09-2017, the 2<sup>nd</sup> respondent has lodged the present complaint on 08-12-2017 alleging trespass etc. Though the same was referred, without considering the same, the Investigating Officer has laid charge sheet against the petitioners herein. Therefore, the contents of the charge sheet in C.C.No.2192 of 2018 are contrary to the findings of the Court below in common order dated 07-09-2017.

In view of the same, matter requires examination.

Therefore, there shall be stay of all further proceedings including the appearance of the petitioners herein / A-1 to A-14 only in C.C.No.2192 of 2018 pending on the file of the XXXIII Addl. Metropolitan Magistrate, Cyberabad at Malkajgiri, Ranga Reddy District.
