WHEREAS the Petitioner above named through his Advocate Sri K.Pradeep Reddy, presented this petition under Article 226 of the Constitution of India, praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to Issue a Writ of Certiorari calling for the entire record pursuant to the impugned order Dated 16.04.2024 in Appeal No.S1/428/2024 on the file of the Respondent No.2 herein which confirmed the order Dated 20.02.2024 in Application No.A/993/2024 of Respondent No.3 is illegal, without assigning any reason, bad under law, arbitrary, unjust, without appreciation of facts on record and in violation of Articles 14 and 21 of the Constitution of India and consequently to Set-aside the order Dated 20.02.2024 in Application No.A/993/2024 of Respondent No.3 which confirmed the order Dated 20.02.2024 in Application No.A/993/2024 of Respondent No.3 thereby to dismiss the Application No.A/993/2024 on the file of Respondent No.3;

AND WHEREAS the High Court upon perusing the petition and affidavit filed therein, and upon hearing the arguments of Sri K.Pradeep Reddy, Advocate for the Petitioner, directed issue of notice to the Respondent No.4 herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 12-6-2024 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

IA NO: 1 OF 2024:

Petition under Section 151 of CPC, praying that in the circumstances stated in the affidavit filed in the writ petition, the High Court may be pleased to Stay all further proceedings of the order Dated 20.02.2024 in Application No.A/993/2024 on the file of Respondent No.3, pending disposal of WP No. 12171 of 2024, on the file of the High Court.

The Court made the following: ORDER:

Issue notice to respondent No.4.

Learned counsel for the petitioner is also permitted to take out personal notice to respondent No.4 by 'RPAD' and file proof of service in the Registry by the next date of hearing.

According to the petitioner, respondent No.3 has passed the order, dated 20.02.2024, in Case No.A/993/2023, without assigning any reasons and the said order was upheld by the Commissioner/Director, Appellate Authority, Department for Empowerment of Persons with Disabilities, Senior Citizens & Transgender Persons, Government of Telangana *vide* his order, dated 16.04.2024 in Appeal No.S1/428/2024, without assigning any reasons.

Though in the impugned orders, there is a mention about the petitioner and his wife harassed respondent No.4 by beating her with cutting player and her left thumb finger was badly injured, she has not lodged any complaint against the petitioner and his wife.

During the course of hearing, it is brought to the notice of this Court that respondent No.4 and her younger son are staying in the very same property. Petitioner is also staying in the same house.

In the light of the same, the matter requires examination.

Hence, there shall be interim suspension of the order, dated 20.02.2024, in Case No.A/993/2023 passed by respondent No.3 till 12.06.2024.

List the matter on 12.06.2024.
