The Court made the following: ORDER

HON'BLE SMT. JUSTICE G. ANUPAMA CHAKRAVARTHY CRIMINIAL PETITION No.5933 of 2023

ORDER:

This Criminal Petition is filed under Section 482 of Cr.P.C. by the petitioners-accused Nos.1 to 6 to quash the proceedings in C.C.No.492 of 2023 on the file of XII Additional Metropolitan Magistrate, R.R. District against them.

- 2. Heard learned counsel for petitioners and Sri S.Ganesh, learned Assistant Public Prosecutor for respondent No.1-State.
- 3. It is the contention of the learned counsel for the petitioners that basing on the report of respondent No.2, the case was registered against them for the offences under Sections 406, 420, 120-B r/w. 34 of IPC.
- 4. It is contended by the learned counsel for petitioners that the subject matter of complaint is purely civil in nature as it relates to development of land, and therefore, it is a fit case to quash the proceedings against the petitioners.
- 5. On the other hand, it is contended by the learned Assistant Public Prosecutor that it is not a case to quash the proceedings at this stage and the matter requires to be tried.

- 6. Taking into consideration the fact that there are no specific allegations against petitioner Nos.2 to 6/A-2 to A-6 and the allegations are only against petitioner No.1/A-1, this court is of the considered view that it is a fit case to dispense with the presence of petitioner No .2 to 6 during the course of trial.
- 7. Accordingly, the appearance/attendance of petitioner Nos.2 to 6 before the XII Additional Metropolitan Magistrate, R.R. District in C.C.No.492 of 2023 is dispensed with unless their presence is required by the trial Court for a specific purpose or at the time of recording their examination under Section 313 Cr.P.C. and on the da e of pronouncement of judgment.
- 8. The Cr minal Petition is accordingly disposed of Pending miscellaneous applications, if any, shall stand closed.
