#### ORDER:

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioners/Accused, to quash the proceedings against them in FIR No.524 of 2023 of Malkajgiri police station, Rachakonda Commissionerate on the file of the Prinicipal Junior Civil Jude-cum-Metropolitan Magistrate, Medchal-Malkajgiri, at Malkajgiri registered for the offences punishable under Sections 448, 323,509 and 506 read with 34 of the Indian Penal Code.

- 2. When the matter is taken up for hearing, learned Assistant Public Prosecutor submits that police have already filed charge-sheet before the learned Metropolitan Magistrate, Medchal on 28.06.2023. Therefore, the cause in the Criminal Petition does not survive for adjudication.
