The said order was passed

by following the judgment in W.A.No.1195 of 2004, dated 03.08.2004. The petitioner herein is stated to have purchased the subject property from the appellants in W.A.No.528 of 2005 under registered sale deed dated 21.03.2021.

In view of the same, there shall be interim direction as prayed for.
