#### ORDER:

Heard Mr. Vivek Jain, learned counsel for the appellant; Mr. N.Ashok Kumar, learned counsel for respondents No.1 and 2; and Mr. Pramod Singh, learned counsel for respondents No.3, 4 and 5.

Having regard to our order dated 20.06.2022, and on perusal of the materials on record, we are of the view that it would be appropriate to appoint an Advocate-Commissioner for inspection of the subject building and for submission of report for consideration of the Court.

Considering the above, we appoint Ms. K.Mamata Choudhary, a counsel of this Court, as Advocate Commissioner.

Court Officer to furnish a complete set of appeal papers to learned Advocate-Commissioner, who shall physically inspect the subject building and thereafter, submit report before this Court by 19.07.2022.

The fees of learned Advocate Commissioner is fixed at Rs.50,000/-(Rupees fifty thousand only) to be paid by the appellant.

Till 19.07.2022, status quo order passed on 20.06.2022 shall continue.
