WHEREAS the Petitioner above named through her Advocate Sri A Phani Bhushan presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ order or direction more particularly one in the nature of writ of mandamus declaring the action of the 1st respondent in terminating the services of the petitioner as Circle Based Officer vide HR/L&D/OW/342 dated 28-01-2022 and the action of the 2nd respondent in not considering the appeal/representation of the petitioner dated 30-03-2022 as being arbitrary, illegal, unjust and violative of Article 14, 16 and 21 of the Constitution of India and consequently hold that the petitioner is entitled to be re-inducted as Circle based officer with all consequential benefits;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri A Phani Bhushan, Advocate for the Petitioner and Sri S Arun Kumar for the respondents, directed issue of notice to the Respondents, herein to show cause as to why this WRIT PETITION should not be admitted.


