ORDER

Heard both sides. Perused the record.

As seen from the material placed on record, the petitioner/A2 has fallen due some amount to the de facto complainant towards maintenance charges of Aditya Empress Towers belonging to A3 in the subject case.

It appears that the civil dispute in between the parties to the litigation is given the colour of a criminal one.

The contentions raised need a detailed examination.

Under these circumstances, the interest and personal liberty of the petitioner/A2 needs protection.

Accordingly, the investigating officer/Station House Officer concerned shall refrain from taking any coercive steps, including arrest, against the petitioner/A2, till 24.11.2021. However, investigation may go on. petitioner/A2 shall cooperate with the Investigating Officer, for smooth conduct of investigation.
