ORDER: (Per Hon'ble Sri Justice P.Naveen Rao)

This writ petition is filed challenging the Sale notice dated 10.06.2022, where under, auction was proposed to be conducted on 25.07.2022.

- 2. Though remedy of appeal is available before the Debts Recovery Tribunal, this writ petition is filed on the ground that there is urgency in the matter as sale is proposed to be conducted today and presiding officer was not available in the Debts Recovery Tribunal-II at Hyderabad (for short 'the Tribunal').
- Today, the Court is informed that presiding officer to the Debts Recovery Tribunal-II is assuming office today.
- 4. Ordinarily, we would have relegated the party to avail the remedy before the Tribunal including seeking interim protection, but having regard to the fact that sale is scheduled to be held today only, we are inclined to grant interim protection till availing the remedy before the Tribunal.
- 5. Therefore, the Writ Petition is disposed of directing the respondent that sale proceedings may go on, but not to finalize the sale proceedings for a period of four weeks. In the meantime, petitioner shall avail the remedy

provided before the Tribunal. Pending miscellaneous petitions, if any, shall stand closed.
