ORDER:

Heard learned counsel for the petitioner and learned Assistant Government Pleader for Stamps and Registration appearing for the respondents. With their consent, the writ petition is being taken up for disposal at the admission stage itself.

2. This writ petition is filed for seeking the following prayer:-

"to declare the inaction of the official Respondents in not taking any action on the representation of the petitioner dated 29/04/2019 and 26/08/2021 and 17/01/2022 21/01/2022 or direction to Respondents no.1 to 3 not renewing the Notary of license by considering the renewal application from 25/05/2017 to 25/05/2022 TO 25/05/2027 for further period of 5 years the petition as illegal, arbitrary and consequently direct the respondents to consider the case of the petitioner for renewal of notary license and issue renewal certificate of practice by considering the renewal application of the petitioner in accordance with Notary Rules 1952."

3. Learned counsel for the petitioner submitted that petitioner is an advocate and he was practicing notary by virtue of permission granted *vide* G.O.Ms.No.354 Revenue dated 25.05.2012. It is further submitted that after expiry of the above said permission the petitioner made representations dated 29.04.2019, 26.08.2021, 17.01.2022 and 21.01.2022 and requested respondent authority to renew notary license and the same is still pending for consideration and pray this Court to direct the respondent authority to

consider the petitioner's representations dated 29.04.2019 26.08.2021, 17.01.2022 and 21.01.2022 and pass appropriate orders in a time bound period.

- 4. Learned Assistant Government Pleader for Stamps and Registration submits that if the representations dated 29.04.2019, 26.08.2021, 17.01.2022 and 21.01.2022 are still pending for consideration, the respondent authorities may be directed to dispose of the same and pass appropriate orders in accordance with law.
- 5. Recording the submission made by the learned counsel appearing on either side and without going into the merits of the case, this writ petition is disposed of directing the respondent authority to dispose the petitioner's representation; dated 29.04.2019, 26.08.2021, 17.01.2022 and 21.01.2022 and pass appropriate orders strictly in accordance to law, as expeditiously as possible, preferably, within a period two (02) weeks from the date of receipt of a copy of this order and communicate the same to the petitioner.
- 6. Accordingly, Writ Petition is disposed of Miscellaneous applications, it any pending, shall stand closed.
