The Court made the following COMMON JUDGMENT:

THE HON'BLE SRI JUSTICE ABHINAND KUMAR SHAVILI AND THE HON'BLE SRI JUSTICE NAMAVARAPU RAJESHWAR RAO Writ Appeal Nos.1167, 1168, 1182 of 2023 & 50 of 2024

COMMON JUDGMENT: (Per Hon'ble Sri Justice Abhinand Kumar Shavili)

All these Writ Appeals are being disposed of by way of this common order, since the issue raised in these Writ Appeals is one and the same.

- 2. All these Writ Appeals are filed against the common order, dated 21.07.2023, passed by a learned Single Judge of this Court in W.P.Nos.6985, 6930, 11988 & 6541 of 2023 respectively.
- 3. Heard Smt. Uma Devi, learned Standing Counsel appearing for the appellant and Sri Pratap Narayan Sanghi, learned Senior Counsel representing Sri Avadesh Narayan Sanghi, learned counsel appearing for respondents in W.A.Nos.1167 & 1182 of 2023 and 50 of 2024 and Sri V. Gopala Rao Amancharla, learned counsel appearing for respondents in W.A.No.1168 of 2023.

- 4. For the sake of convenience, the facts in Writ Appeal No.50 of 2024 are hereunder discussed.
- 5. Learned Standing Counsel appearing for appellant had contended that the respondents are working as casual workers with the appellant-Bank since several years and they have submitted representations regularise their services by formulating a scheme in accordance with the law laid down by the Hon'ble Supreme Court in State of Karnataka & others v. Uma Devi & others1. When the case of the respondents was not considered, they have approached this Court by filing W.P.No.15294 of 2014 and batch contending that the appellant-Bank should frame one-time scheme for regularisation of their services in terms of the law laid down by the Hon'ble Supreme Court in Uma Devi's case (supra) and this Court was pleased to dispose of the said writ petition vide order, dated 09.01.2020 by following the orders passed in W.P.No.24799 of 2011, dated 27.12.2017 and directed the appellant-Bank to formulate a scheme to

regularise the services of the respondents. Aggrieved by the said order passed by the learned Single Judge, the appellant-Bank has preferred W.A.No.147 of 2020 and batch and the Division Bench of this Court was pleased to dismiss the writ appeal vide order, dated 25.04.2022. Aggrieved by the same, the appellant-Bank has carried the Hon'ble Supreme Court by matter the S.L.P.No.12973 of 2022 and batch. The Hon'ble Supreme Court was pleased to dispose of the said SLP preferred by the appellant-Bank vide order, dated 12.08.2022. Pursuant to the order passed by this Court and the Hon'ble Supreme Court, the Board of Directors of the appellant-Bank have formulated a scheme on 13.02.2023. Aggrieved by the formulation of the scheme for regularising the services of the respondents by the appellant-Bank, the respondents have once again, approached this Court by filing the present W.P.No.6541 of 2023 and batch contending that fixed the cut-off date as appellant-Bank has 31.12.2017 for considering the cases of the respondents for regularising their services and the scheme contemplates that such of those persons who have completed 10 years of

service as on 31.12.2017, alone are eligible for consideration.

Learned Standing Counsel for the appellant had 6. further contended that the respondents were also aggrieved by the assessment of suitability in the form of examination. The respondents have contended that the appellant-Bank must regularise their services, without subjecting them to any selections, as admittedly, the respondents were working for more than a decade. The learned Single Judge was pleased to set aside condition No.2 (2), which deals with the eligibility for consideration of their cases by fixing cut-off date as 31.12.2017. The learned Single Judge has erroneously directed that the cut-off date should be fixed as and when the scheme of regularisation has been announced. Learned Standing Counsel further contended that from 31.12.2017, all causal labour service conditions were altered and all the respondents were engaged on outsourcing basis and not being continued as casual workers, and therefore, the appellant-Bank was justified in taking 31.12.2017 as cut-off date. Learned Standing Counsel

further contended that the learned Single Judge could not have altered the cut-off date as fixed in the said scheme. Learned Standing counsel further contended that aggrieved by that portion of the learned Single Judge's order, where the learned Single Judge has enlarged the cut off date from 31.12.2017 to 13.02.2023 i.e., till the date of issuance of the scheme, the present Writ Appeal is filed. Learned Standing Counsel further contended that though the appellant has raised other issues in respect of conducting of tests and other issues, but they are not pressing all those contentions. Therefore, appropriate orders be passed in the writ appeal by setting aside the order, dated 21.07.2023 passed in W.P.No.6541 of 2023 and batch by the learned Single Judge, wherein, the learned Single Judge has enlarged the scope of cut off date from 31.12.2017 to 13.02.2023 and accordingly allow the writ appeal.

7. On the other hand, learned counsel for the respondents had contended that in respect of similarly situated Bank i.e., Chaitanya Godavari Grameena Bank is

concerned, the said Bank had also come up with a regularisation scheme, wherein, the cut-off date was fixed as 31.12.2017 and as the writ petition preferred by the casual workers against the said Bank was disposed of on 21.12.2017. Therefore, fixing the cut-off date in that case as 31.12.2017 was correct. But, when it comes to the present case, writ petition preferred by the respondents was disposed of by this Court on 09.01.2020. Later, the appellant-Bank has carried the matter right upto the Hon'ble Supreme Court and only when the case of the appellant-Bank was dismissed by the Hon'ble Supreme Court on 12.08.2022, the appellant-Bank has come up with a scheme of regularisation. The learned Single Judge has relied upon the judgment of the Hon'ble Supreme Court Narendra Kumar Tiwari v. Jharkhand², wherein the Hon'ble Supreme observed that the cut-off date fixed in Uma Devi's case (supra 1) is 10.04.2006 and when it comes to the State of Jharkhand, which was formed on 15.11.2000, if the said cut-off date is to be applied, none of the casual

workers/employees working in the State of Jharkhand would be entitled for regularisation and has rightly came to a conclusion that the cut off date should be fixed as and when the scheme of regularisation is issued. Therefore, the learned Single Judge has rightly followed the judgment of the Hon'ble Supreme Court in *Narendra Kumar Tiwari's* case (supra 2) and enlarged the cut-off date from 31.12.2017 to 13.02.2023, i.e., the date which the appellant-Bank has come up with the scheme of regularisation. Therefore, there are no merits in the writ appeals and the same are liable to be dismissed.

8. This Court, having considered the rival submissions made by the parties, is of the view that the learned Single Judge was justified in setting aside that portion of the scheme, where the cut-off date is prescribed as 31.12.2017. When the appellant-Bank has come up with a scheme of regularising the services of casual workers on 13.02.2023, the learned Single Judge was justified in directing the appellant-Bank to fix '13.02.2023' as cut-off date instead of '31.12.2017' by following the law laid down

by the Hon'ble Supreme Court in **Narendra Kumar Tiwari's** case (supra 2). Therefore, this Court is not inclined to interfere with the orders passed by the learned Single Judge.

9. With the above said observations, all these Writ Appeals are dismissed. No costs.

As a sequel, miscellaneous applications pending if any, shall stand closed.
