i. declaring the inaction of the 1st respondent in directing the 3rd respondent to implement the Circular dt.02-04-2012 of the 2nd respondent, Memo dt. 13-09-2012 of the 2nd respondent, Memo dt. 11-03-2010 of the 1st respondent, Memos dt.28-03-2013, 06-02-2012 and 28-03-2013 of the 2nd respondent in favour of the contract labour working under his control or in his power generation station is neither sustainable in the eye of law nor facts of the case as illegal, arbitrary,

discriminative, unfair labour practice, non-application of mind and opposed to the 'doctrine of legitimate expectation', 'doctrine of promissory estoppel' besides violative of Arts.14 and 16 of the Constitution of India; and

ii. consequently, direct the 1st respondent to take all necessary steps for the welfare of the contract labour as per statutory and constitutional provisions; and also direct the 3rd respondent to implement the Circular dt.02-04-2012 of the 2nd respondent, Memo dt.13-09-2012 of the 2nd respondent, Memo dt.11-03-2010 of the 1st respondent, Memos dt.28-03-2013, 06-02-2012 and 28-03-2013 of the 2nd respondent.

This Writ Petition is filed seeking to direct the 1st respondent to take all necessary steps for the welfare of the contract labour as per statutory and constitutional provisions; and also direct the third respondent to implement the Circular dated 02.04.2012 of the second respondent, Memo dt.11.03.2010 of the first respondent, Memos dt.28.03.2013, 06.02.2012 and 28.03.2013 of the second respondent.

- 2) When the matter is taken up for hearing, the learned counsel for the petitioner-Union has submitted that incompliance of the interim order passed by this Court on 02.01.2014, the respondents have passed a Speaking Order dated 29.03.2014 and therefore no further orders are necessary to be passed in the present Writ Petition.
- 3) Recording the above made submission, the Writ Petition is disposed of granting liberty to the petitioner to challenge the order dated 29.03.2014, if it is so advised.
