In view of the above, there shall be interim suspension of operation of the Gazette Notification No.46-A dated 20.12.2001 to the extent of the properties of the petitioner i.e., Acs.0-30 guntas in Survey No.120AA, Ac.0-33 guntas in Survey No.119, Acs.0-17 guntas in Survey No.118 and Acs.5-00 guntas in Survey No.195/AA/1, total land to an extent of Acs.7-00 guntas, situated in Kucharum Village, Manoharabad Mandal (earlier part of Toopran

Mandal/Gajwel Taluk), Medak District, until further orders. Any alienation made by the petitioner shall be subject to further orders of this Court.
