ORDER:

This Writ Petition is filed for the following substantive relief:

".....issue a Writ, Order or Direction more particularly one in the nature of Writ of Mandamus declaring the in-action of the respondent No.3 in receiving the documents for registration of agricultural lands of petitioner No.1 in Survey Numbers 498-1, 498-4, 511. 513, 514-2, 516, 517 and 518 with extents — Ac 6.28 cents, Ac 7.88 cents, Ac.2.02 cents, Ac.1.95 cents, Ac.0.47 cents, Ac.0.47cents, Ac.0.18 cents and Ac.0.36 cents respectively, lands of petitioner No.2 in Survey Numbers 498-1, 498-4, 509, 511. 513, 514-2, 516 517, 518 and 524-2 with extents Ac 5.39 cents, Ac.2.56 cents, Ac.1.34 cents, Ac.1.73 cents, Ac.1.70 cents, Ac.0.40 cents, Ac.0.40 cents,

Ac.0.15 cents, Ac.0.31 cents and Ac.1.71 cents respectively, lands of petitioner No.3 in Survey Numbers 498-1, 498-4, 507/2. 511, 514-2, 517 and 518 with extents Ac 8.08 cents, Ac.1.04 cents, Ac.0.33 cents, Ac.1.50 cents, Ac.0.61 cents, Ac.0.25 cents and Ac.0.47 cents respectively, lands of petitioner No.4 in Survey Numbers 498-1, 498-4, 511, 514-2, 517 and 518 with extents Ac.8.08 cents, Ac.1.04 cents, Ac.1.50 cents, Ac.0.61 cents, Ac.0.25 cents and Ac.0.47 cents respectively, lands of petitioner No. 5, 498-1, 498-4, 509, 511. 513, 514-2, 516, 517 and 518 with extents Ac 2.70 cents, Ac.0.30 cents, Ac.0.67 cents, Ac.0.62 cents, Ac.0.85 cents. Ac.0.20 cents. Ac.0.20 cents. Ac.0.08 cents and Ac.0.16 cents respectively, lands of petitioner No. 6 in Survey Numbers 498-1, 498-4, 509, 511, 513, 514-2, 516, 517 and 518 with extents Ac.2.69 cents, Ac.0.94 cents, Ac.0.67 cents, Ac.0.20 cents, Ac.1.01 cents, Ac.0.85 cents, Ac.0.20 cents, Ac.0.07 cents and Ac.0.15 cents respectively, situated at Bodevandlapally village, Yerravaripalem Mandal, Chittoor District, only on the ground that small extents in the survey numbers are included in the list of Government lands as arbitrary and illegal and also violative of Section 22-A of the Registration Act and also in violation of the fundamental and Constitutional rights guaranteed to the petitioners under Articles 14, 19, 21 & 300-A of the Constitution of India and consequently, direct the respondent No.3 to receive and register the lands of the petitioners."

At the hearing, learned counsel for the petitioners submitted that W.P.No.38400 of 2012 filed raising similar issues to those raised in this Writ Petition was allowed by this Court by order, dated 21.01.2013.

Learned Assistant Government Pleader for Revenue has conceded to this position.

In the light of the above submission of learned counsel for the petitioners, this Writ Petition is allowed in terms of order, dated 21.01.2013, in W.P.No.38400 of 2012 with the direction that the reasons and directions contained therein shall form part of this order.
