WHEREAS the Petitioner above named through his Advocate Sri. VIJAY B PAROPAKARI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction, more particularly a Writ in nature of Writ of Mandamus, declaring the action of the Respondents, more particularly that of the 2nd Respondent in orally directing to move out the two cows and a bull from the Premises in Villa No. 194 in the Gated Community of "Neighbourhood" at the behest of the Secretary without issuing any prior notice or without following the due procedure of law is challenged in this Writ Petition as being arbitrary, illegal and violative of Articles 14, 19 (1) (g) and 21 of the Constitution of India and consequently direct the 2nd Respondent not to forcibly move the 'PUNGANUR' cows from the custody and premises in Villa No. 194, "The Neighbourhood", Gundlapochampally Road, Qutubullapur Mandal, Kompally Village, Medchal - Malkajgiri District - 500 100, belonging to the Petitioner without any prior notice or without following the due process of law;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri VIJAY B PAROPAKARI Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
