ORDER

This Petition has been filed seeking to direct the respondents to release and pay the tasdik allowance and government waste pending for the Nagore Dargah by considering the representation dated 21.10.2022.

2. The petitioner claims that the petitioner Dargah is a notified Waqf by Gazette Notification vide GS.187/TNJ dated 24.12.1958. It is their grievance that the official respondents ought to release the pending tasdik allowance and government waste to their Dargah and the same is not yet releese. Hence, the petitioner made a representation dated 21.10.2022 seeking for releasing the same, which is pending without consideration till date. Hence, this writ petition.

Government Pleader for the respondents 1 to 3 and perused the materials placed on record.
