- 2. During the course of submissions, the learned counsel appearing for the revision petitioner submitted that the petitioner is prepared to vacate the said premises within a period of four months from today. He has also filed an affidavit in support of the same.
- 3. In view of the undertaking given by the petitioner by way of an affidavit, the revision petitioner is directed to vacate the schedule premises on or before 15.08.2023. Further, the petitioner is directed to pay the monthly rents regularly until he vacates on 15.08.2023.
  - 4. The said affidavit filed by the petitioner is taken on record.
- 5. Accordingly, the Civil Revision Petition is disposed of. There shall be no order as to costs. Consequently, the connected miscellaneous petition is closed.
