Prayer in WP(MD). 16325/ 2021 :

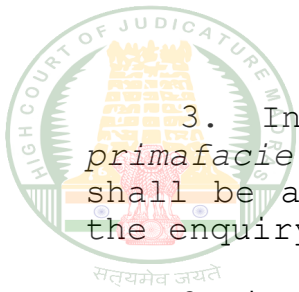
